### **EQUIPMENT:**

Equipment and systems covered by this certificate are as follows:

The Model L1319 series of luminaires is suitable for use in hazardous location classified as Zone 1, Zone 2, Zone 21 and Zone 22. This luminaire consists of three interconnecting "db"/"tb" chambers: one is the top cover for wiring connection to cable gland, the others are the LED array chambers. The enclosure material is aluminum alloy. The light-transmitting parts are made of tempered flat glass. The gasket is used to maintain the IP rating. The entry for wiring through integral cable gland maintains the degree of protection. Unused entries are fitted with blanking elements to maintain the degree of protection.


